

CITY COUNCIL

July 1, 2013

The July 1, 2013 City Council meeting was called to order at 7:30 p.m. in Council Chambers by Don Spiegel, President. A moment of silence was observed followed by the Pledge of Allegiance to the Flag of the United States of America. The minutes of the June 17, 2013 City Council meeting, having been mailed to each City Council member, were approved as received.

A motion was made by Mr. Spiegel, seconded by Mr. Roberts, to remove Ordinance No. 134-12 from the table. Upon Roll Call, all members voted Yes. The President declared the motion carried.

A motion was made by Mr. Thornton, seconded by Mr. Swinehart, to place Ordinance No. 134-12 entitled, "AN ORDINANCE TO APPROVE A PETITION FOR DETACHMENT OF TERRITORY LOCATED WITHIN THE CITY OF UPPER SANDUSKY CONTAINING 134.584 ACRES, MORE OR LESS, IN THE COUNTY OF WYANDOT, STATE OF OHIO, AND IN THE TOWNSHIP OF CRANE.", on its second reading by title only. Upon Roll Call, all members voted Yes; the President declared the motion carried. The Clerk read Ordinance No. 134-12 for the second time by title only.

A motion was made by Mr. Swinehart, seconded by Mr. Thornton, for the adoption of Ordinance No. 134-12. Upon Roll Call, all members voted Yes. The President declared the motion carried and Ordinance No. 134-12 was duly adopted.

A motion was made by Mr. Swinehart, seconded by Mr. Smith, to place Resolution No. 137-12 entitled, "A RESOLUTION AUTHORIZING THE CITY TO RECOMMEND A RESIDENTIAL ENROLLMENT PROGRAM WITH BORDER ENERGY OFFERING RESIDENTS OF THE CITY OF UPPER SANDUSKY, OHIO A 12% DISCOUNT OFF OF AEP'S PRICE TO COMPARE THROUGH DECEMBER 31, 2014, AND DECLARING THIS ACT AN EMERGENCY.", on its second reading by title only. Upon Roll Call, all members voted Yes; the President declared the motion carried. The Clerk read Resolution No. 137-12 for the second time by title only.

A motion was made by Mr. Swinehart, seconded by Mr. Spiegel, for the adoption of Resolution No. 137-12. Upon Roll Call, all members voted Yes. The President declared the motion carried and Resolution No. 137-12 was duly adopted.

Mr. Swinehart commented that it is nice to see that the City parks are being used a great deal.

There being no further business, the President declared the meeting adjourned.
