

BUDGET HEARING

CITY COUNCIL

July 5, 2016

The July 5, 2016 City Council meeting was called to order at 7:30 p.m. in Council Chambers by Don Spiegel, President. A moment of silence was observed followed by the Pledge of Allegiance to the Flag of the United States of America. Several of the visitors addressed City Council expressing their approval and disapproval of the City proposed Yard Maintenance legislation, Ordinance No. 232-12. Mr. Ellis explained the steps for enforcement of the proposed legislation.

A motion was made by Mr. Blocksom, seconded by Mr. Thornton, to place Ordinance No. 231-12 entitled, "AN ORDINANCE AUTHORIZING THE PURCHASE OF A 2016 DODGE RAM 3500 2WD SERVICE UTILITY BODY PICK-UP TRUCK.", on its second reading by title only. Upon Roll Call, all members voted Yes; the President declared the motion carried. The Clerk read Ordinance No. 232-12 for the second time by title only.

A motion was made by Mr. Shumaker, seconded by Mr. Thornton, for the adoption of Ordinance No. 231-12. Upon Roll Call, all members voted Yes. The President declared the motion carried and Ordinance No. 231-12 was duly adopted.

A motion was made by Mr. Roberts, seconded by Ms. Karg, to place Ordinance No. 232-12 entitled, "AN ORDINANCE CREATING CHAPTER 1139 OF THE CODIFIED ORDINANCES OF THE CITY OF UPPER SANDUSKY, OHIO, ESTABLISHING RULES FOR THE MAINTENANCE OF PERSONAL PROPERTY IN OR ON THE EXTERIOR AREAS OF RESIDENTIAL PROPERTIES IN THE CITY OF UPPER SANDUSKY, OHIO, AND ESTABLISHING PENALTIES FOR VIOLATIONS OF CHAPTER 1139.", on its second reading by title only. Upon Roll Call, all members voted as follows:

The President declared the motion carried by a 4-2 vote and Ordinance No. 232-12 was duly adopted.

Discussion was held concerning the 2017 estimate of budget revenues, as reviewed in the Budget Hearing held prior to this meeting.

A motion was made by Mr. Spiegel, seconded by Mr. Thornton, to approve the submission of the 2017 budget revenues to the Wyandot County Auditor. Upon Roll Call, all members voted Yes. The President declared the motion carried.

Mayor Washburn thanked the Chamber of Commerce, the donors, and volunteers for organizing, contributing, and helping with the fireworks that were held on Saturday, July 2, 2016 at the high school.

Mayor Washburn recognized the organizers of Wyanstock that was held at the fairgrounds on Saturday, July 2, 2016.

Mayor Washburn expressed appreciation to Mr. Dan Newell who provided a cooler of water and Gatorade for a City crew doing roadwork on a recent hot day in his neighborhood.

It was noted that the Fire Department's annual Chicken Barbeque held on Monday, July 4, 2016 was a success.

City Council members reviewed the Income Tax Collections and Transient Guest Tax Collections reports as of June 30, 2016.

There being no further business, the President declared the hearing adjourned.
