

CITY COUNCIL

June 20, 2016

The June 20, 2016 City Council meeting was called to order at 7:30 p.m. in Council Chambers by Don Spiegel, President. A moment of silence was observed followed by the Pledge of Allegiance to the Flag of the United States of America. City Council members present were Don Spiegel, Bill Thornton, Bob Blocksom, Roxie Karg, and Tom Shumaker. Scot Swinehart and Rick Roberts were absent.

Visitors to the meeting addressed City Council concerning the proposed Yard Maintenance regulations addressed in Ordinance No. 232-12.

A motion was made by Mr. Thornton, seconded by Ms. Karg, to place Ordinance No. 230-12 entitled, "AN ORDINANCE TO MAKE SUPPLEMENTAL APPROPRIATIONS TO THE ANNUAL APPROPRIATIONS ORDINANCE NO. 216-12, TO MAKE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF UPPER SANDUSKY, STATE OF OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2016.", on its second reading by title only. Upon Roll Call, all members voted Yes; the President declared the motion carried. The Clerk read Ordinance No. 230-12 for the second time by title only.

A motion was made by Mr. Blocksom, seconded by Mr. Shumaker, for the adoption of Ordinance No. 230-12. Upon Roll Call, all members voted Yes. The President declared the motion carried and Ordinance No. 230-12 was duly adopted.

A motion was made by Mr. Thornton, seconded by Ms. Karg, to place Ordinance No. 231-12 entitled, "AN ORDINANCE AUTHORIZING THE PURCHASE OF A 2016 DODGE RAM 3500 2WD SERVICE UTILITY BODY PICK-UP TRUCK.", on its first reading by title only. Upon Roll Call, all members voted Yes; the President declared the motion carried. The Clerk read Ordinance No. 231-12 for the first time by title only.

A motion was made by Ms. Karg, seconded by Mr. Thornton, to place Ordinance No. 232-12 entitled, "AN ORDINANCE CREATING CHAPTER 1139 OF THE CODIFIED ORDINANCES OF THE CITY OF UPPER SANDUSKY, OHIO, ESTABLISHING RULES FOR THE MAINTENANCE OF PERSONAL PROPERTY IN OR ON THE EXTERIOR AREAS OF RESIDENTIAL PROPERTIES IN THE CITY OF UPPER SANDUSKY, OHIO, AND ESTABLISHING PENALTIES FOR VIOLATIONS OF CHAPTER 1139.", on its first reading by title only. Upon Roll Call, all members voted as follows:

The President declared the motion carried by a 3-2 vote. The Clerk read Ordinance No. 232-12 for the first time by title only.
