

CITY COUNCIL

May 9, 2016

The May 9, 2016 special City Council meeting was called to order at 7:30 p.m. in Council Chambers by Don Spiegel, President. City Council members present were Roxie Karg, Rick Roberts, Tom Shumaker, Don Spiegel, Bill Thornton, and Bob Blocksom. Scot Swinehart was absent.

Others present included: Scott Washburn, Mayor; Mark Ellis, Law Director; Aaron Putnam, Wastewater Treatment Plant Supervisor; Todd Jenkins, Peterman Associates; Alissa Paoella, Daily Chief Union; and Sarah Bennett, Clerk.

The purpose of this meeting was to hear the first reading of legislation to approve the lowest and/or best bid received for the Sewer Separation Project.

Mr. Jenkins reviewed the following bids received for the Sewer Separation Project:

Speer Brothers, Inc. 3812 Old Railroad Road Sandusky, Ohio 44870	-	\$7,059,612.50 (base bid only)
Elite Excavating Company of Ohio, Inc. 4500 Snodgrass Road Mansfield, Ohio 44093	-	\$7,097,000.00 (base bid) + \$ 60,000.00 (alternate) \$7,157,000.00 (total bid)
Helms and Sons Excavating, Inc. 1753 Lima Avenue Findlay, Ohio 45840	-	\$7,140,824.75 (base bid only)

I was noted that Peterman Associates and the Service Committee have recommended to City Council to approve the bid from Underground Utilities, Inc. for this project.

Mr. Jenkins explained the locations where work will take place under this project including Seventh Street, Eighth Street, Warpole Street, and Wyandot Avenue. The project will take ten to twelve months to complete and they will work around the car show to be held in September. Upon adoption of the legislation by City Council to approve the bid, the financing will be finalized and contracts are expected to be signed in late June and construction of the project will then proceed.

A motion was made by Mr. Blocksom, seconded by Mr. Thornton, to place Ordinance No. 228-12 entitled, "AN ORDINANCE TO APPROVE A BID SUBMITTED FOR THE SEWER SEPARATION PROJECT, AND DECLARING THIS ACT AN EMERGENCY.", on its first reading by title only. Upon Roll Call, all members voted Yes; the President declared the motion carried. The Clerk read Ordinance No. 228-12 for the first time by title only.

There being no further business, the President declared the meeting adjourned.
