A motion was made by Mr. Korte, seconded by Mr. Blackburn, for the approval and payment of bills totaling \$172,233.59. Upon Voice Vote, all members voted Yes. The Chairman declared the motion carried.

The minutes of the July 9, 2018 Park Board meeting, having been mailed to each Park Board member, were approved as received.

It was noted that a letter from the family of Robby Lee was received expressing their appreciation for the new Robby Lee Memorial Courts at Bicentennial Park.

Mr. Niederkoehr reported that the water and sewer lines for the splash pad, to be located in Bicentennial Park, have been installed and are ready to be hooked up. Electric to this area needs to be done. The contractor for this project will begin his preliminary work on August 20, 2018 and return to complete the project at the end of September. The Parks Department will seed the grass in that area following the completion of the project. The splash pad will open in 2019. Mr. Niederkoehr suggested that over the winter months the Park Board discuss details regarding the splash pad including hours of operation, opening and closing dates, and possibly age limits.

Mr. Niederkoehr also reported that this is the last week for the summer help to work in the Parks Department.

Mr. Niederkoehr further noted that the handicap accessible swing set was delivered this week and will be assembled and installed in Bicentennial Park soon. Handicap accessible picnic tables will also be installed on the same concrete pad as the swing set.

Mr. Niederkoehr indicated that additional catch basins for the storm sewer in Harrison Smith Park were recently installed.

Mr. Niederkoehr noted that there is nothing further to report at this time on possible improvements to the dog park.

Discussion was held concerning ways to attract interest in the lifeguarding positions at the pool in 2019. Ideas of a possible bonus or reimbursement for their necessary training were discussed. Miss Catie Richman, Pool Manager, will be asked for her suggestions.

There being no further business, the Chairman declared the meeting adjourned.
