

CITY COUNCIL

August 3, 2015

The August 3, 2015 City Council meeting was called to order at 7:30 p.m. in Council Chambers by Rick Roberts, President. A moment of silence was observed followed by the Pledge of Allegiance to the Flag of the United States of America. City Council members present were Scot Swinehart, Bill Thornton, Bob Blocksom, Roxie Karg, Rick Roberts, and Tom Shumaker. Don Spiegel was absent.

Others present included: Scott Washburn, Mayor; Mark Ellis, Law Director; Mark Droll, City Auditor; John Baldwin; Alissa Paoella, Daily Chief Union; and Sarah Bennett, Clerk.

The minutes of the July 20, 2015 City Council meeting, having been mailed to each City Council member, were approved as received.

The minutes of the July 20, 2015 Service Committee meeting, having been mailed to each City Council member, were reviewed.

The minutes of the July 23, 2015 Board of Zoning Appeals hearing, having been mailed to each City Council member, were reviewed.

A motion was made by Mr. Blocksom, seconded by Mr. Swinehart, to place Ordinance No. 206-12 entitled, "AN ORDINANCE TO APPROVE, ADOPT AND ENACT THE 2015 REPLACEMENT PAGES TO THE CODIFIED ORDINANCES: TO REPEAL ORDINANCES IN CONFLICT THEREWITH: TO PUBLISH THE ENACTMENT OF NEW MATTER: AND DECLARING THIS ACT AN EMERGENCY.", on its second reading by title only. Upon Roll Call, all members voted Yes; the President declared the motion carried. The Clerk read Ordinance No. 206-12 for the second time by title only.

A motion was made by Mr. Swinehart, seconded by Mr. Thornton, for the adoption of Ordinance No. 206-12. Upon Roll Call, all members voted Yes. The President declared the motion carried and Ordinance No. 206-12 was duly adopted.

A motion was made by Mr. Blocksom, seconded by Mr. Swinehart, to place Ordinance No. 207-12 entitled, "AN ORDINANCE TO MAKE SUPPLEMENTAL APPROPRIATIONS TO THE ANNUAL APPROPRIATIONS ORDINANCE NO. 184-12, TO MAKE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF UPPER SANDUSKY, STATE OF OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2015, AND DECLARING THIS ACT AN EMERGENCY.", on its first reading by title only. Upon Roll Call, all members voted Yes; the President declared the motion carried. The Clerk read Ordinance No. 207-12 for the first time by title only.

Mayor Washburn recommended the appointment of Mr. John Walker to fill the unexpired term of Mrs. Linda Geary on the Tree Commission.

A motion was made by Mr. Roberts, seconded by Mr. Thornton, to approve the appointment of Mr. John Walker to the Tree Commission. Upon Roll Call, all members voted Yes. The Chairman declared the motion carried.

The committee formed to address yard maintenance regulations will be meeting again on Monday, August 17, 2015 at 6:30 p.m. in Council Chambers.

Mayor Washburn reminded City Council members of the Open House to be held at The Andersons on August 7, 2015 from 12:00 p.m. to 4:00 p.m.

The Chamber of Commerce annual steak fry will be held on Wednesday, August 12, 2015 at the fairgrounds.

Mr. Droll reviewed the recapitulation for June 2015 with the members of City Council.

There being no further business, the President declared the meeting adjourned.
