

CITY COUNCIL

September 21, 2015

The September 21, 2015 City Council meeting was called to order at 7:30 p.m. in Council Chambers by Rick Roberts, President. A moment of silence was observed followed by the Pledge of Allegiance to the Flag of the United States of America. City Council members present were Roxie Karg, Rick Roberts, Tom Shumaker, Don Spiegel, Bill Thornton, and Bob Blocksom. Scot Swinehart was absent.

Others present included: Scott Washburn, Mayor; Mark Ellis, Law Director; and Sarah Bennett, Clerk.

The minutes of the September 8, 2015 City Council meeting, having been mailed to each City Council member, were approved as received.
