Discussion was held concerning a request for a directional sign to be placed in the city right-of-way on the corner of Tarhee Trail and St. Rt. 53. This sign request was denied.

Discussion was held concerning a request from Lisa Thiel for a curb cut for her property located at 500 North Seventh Street in order to accommodate more parking in this area. The Service Committee will view the area and discuss options at the next meeting.

Discussion was held concerning a "not responsible for accidents" sign at the reservoir. The Law Director will be contacted regarding this matter.

Mr. Dave Westbrook, Water Plant Supervisor, reported on the sludge removal project at the old water plant site.

Discussion was held with Mr. Allen Boes, Street Department Supervisor, regarding several maintenance items. These items included the repair of the grater, tractor and Unit 7 garbage track.

Discussion was held concerning the removal of garage sale signs from poles and city right-of-ways after the sale is over. Possible fines were discussed if the signs are not removed after the sale.

There being no further business, the meeting was adjourned.
