## TOTAL BILLS: \$99,097.12

A motion was made by Mr. Spiegel, seconded by Mr. Rowe, for the approval and payment of bills totaling \$99,097.12. Upon Voice Vote, all members voted Yes. The Chairman declared the motion carried.

The minutes of the August 3, 2015 Service Committee meeting, having been mailed to each Service Committee member, were approved as received.

A date for fall clean-up was discussed.

A motion was made by Mr. Spiegel, seconded by Mr. Latham, to set fall clean-up within the City to be held Monday, September 28, 2015 thru Friday, October 2, 2015. Upon Voice Vote, all members voted Yes. The Chairman declared the motion carried.

Service Committee members reviewed a quote of \$13,750.00 from Zimmerman Paint Contractors Co. for the removal of center line, center line striping, removal of center line and transverse for turn lane, and lump sum striping of turn lane.

A motion was made by Mr. Spiegel, seconded by Mr. Latham, to approve the quote of \$13,750.00 from Zimmerman Paint Contractors Co., as presented. Upon Voice Vote, all members voted Yes. The Chairman declared the motion carried.

It was decided that due to the September 7, 2015 Labor Day holiday, the next Service Committee meeting will be held on Tuesday, September 8, 2015.

Mr. Boes stated that Wyandot Motor Sales currently has a 35' 2008 Ford Bucket Truck on their lot for sale and they are asking \$20,000.00. It was noted that the back of the truck needs to be sandblasted and painted and Wyandot Motor Sales is asking \$5,000.00 to do this work, but Mr. Boes indicated that this could be a winter project for the Street Department employees. It was also noted that the brakes on the vehicle need to be repaired. Mr. Boes was asked to arrange for the Service Committee and the Street Department representatives to take a look at the truck. Mayor Washburn will negotiate the price of the vehicle if the Service Committee is interested in purchasing it.

Mr. Putnam reported that Mr. Todd Jenkins, Peterman Associates, will be meeting with Mr. Mark Droll, City Auditor, tomorrow concerning the City's loan application.

Mr. Putman also reported that the City's blueprints are still under review by the EPA.

Mr. Putnam further reported that no public comments were received after the EPA's draft permit was issued so now the final permit will be issued.

Mr. Boes reported that the City's street sweeper has been repaired and in running.

Mr. Searfoss reported that the five inserta valves have been installed.

Mr. Boes reported on an oxny process was performed on CH 25 to seal the tar and chip. Mr. Boes noted the only approximately fifty (50) cars travel this road daily. Service Committee members requested Mr. Boes periodically check on the road condition under this process.

It was noted that prep work on the roofs on the Safety and Municipal Buildings will begin at the end of September and the project is expected to be completed in mid October.

A motion was made by Mr. Spiegel, seconded by Mr. Rowe, to enter into an executive session to discuss employee discipline. Upon Voice Vote, all members voted Yes. The Chairman declared the motion carried. Upon completion of the executive session, the Service Committee reconvened into regular session.

A motion was made by Mr. Rowe, seconded by Mr. Spiegel, to give Mr. Allen Boes three days off without pay. Upon Voice Vote, all members voted Yes. The Chairman declared the motion carried.
