Mr. Putnam reported on the upcoming public meeting concerning the City's proposed Water Reclamation Facility to be held on Wednesday, December 13, 2017 at 6:00 p.m. at the Wyandot County Emergency Medical Services Building, 401 North Warpole Street.

Mr. Schoenberger reported that he is still waiting on parts to fix equipment damaged at the Water Treatment Plant as a result of a storm that occurred on November 10, 2017 causing power surges.

Mr. Taylor reported that the Street Department will be starting the last round of leaf pick-up tomorrow.

Mr. Taylor also reported that he has been working with Mr. Mark Droll, City Auditor, on the budget for the Street and Sanitation Departments for 2018 which will include a new street sweeper and a new garbage truck.

Mr. Schneider reported that the City's new sewer camera truck was recently delivered.

Mr. Thornton reported that R.A. Bores is done with all of the water line hook-ups as part of the West Water System Improvement Project. They will be returning in the spring to seed the project area and repave West Bigelow Street.

Mr. Thornton also reported that Poggemeyer Design Group has almost completed the process of GPS mapping of water lines within the City.

There being no further business, the Chairman declared the meeting adjourned.
