A motion was made by Mr. Voorheis, seconded by Mr. Rowe, for the approval and payment of bills totaling \$295,934.54. Upon Voice Vote, all members voted Yes. The Chairman declared the motion carried.

The minutes of the May 21, 2018 Service Committee meeting, having been mailed to each Service Committee member, were approved as received.

Service Committee members discussed the request presented by Mr. Taylor at the May 21, 2018 meeting from a resident living at 400 Raybestos Drive for a street light in their area. Service Committee members voiced no objections to the placement of a street light in this area.

Mr. Schoenberger provided more information, as requested by the Service Committee, on a request he presented at the May 21, 2018 meeting concerning a disc golf tournament to be held in mid July and permission to camp at the reservoir the night before the tournament. Mr. Schoenberger indicated that the tournament will be sanctioned and held on Saturday, July 14, 2018 beginning at 9:00 a.m., with approximately twelve individuals interested in camping the night before the tournament. Service Committee members voiced no objections to the individuals camping and indicated that no fire and no alcohol are permitted.

Mr. Taylor reported that he talked with the AEP site manager for their new facility to be located on Tarhe Trail. Mr. Taylor stated that Tarhe Trail will be closed on Thursday of this week for a water tap for the site. Notifications have been made to all businesses in this area regarding the detour as a result of this project.

Mr. Schoenberger reported that the new air compressor for the Water Treatment Plant is scheduled to be shipped on June 7, 2018 and the necessary electrical work for the installation has been completed.

Mr. Taylor reported that the sidewalk from River's Edge to Duck Pond will be poured later this week.

Mr. Taylor also reported that he is currently waiting on Mr. Gary Huffman to finish with farming so work on the City's Street and Alley Program can begin.

There being no further business, the Chairman declared the meeting adjourned.
