A motion was made by Mr. Spiegel, seconded by Mr. Voorheis, for the approval and payment of bills totaling \$606,920.03. Upon Voice Vote, all members voted Yes. The Chairman declared the motion carried.

The minutes of the June 4, 2018 Service Committee meeting, having been mailed to each Service Committee member, were approved as received.

Mr. Putnam reported on issues experienced recently with the lift stations at Duck Pond subdivision. It was noted that the new pumps that were installed failed following heavy rain events and Buckeye Pumps was called to assess the situation and it was determined that the bases were old and faulty. New bases have been installed and the pumps are working well.

Mr. Putnam also reported that the final prints for the proposed Water Reclamation Facility are currently at the printers. Mr. Putnam will be meeting with representatives from AECOM on July 16, 2018 regarding the permit to install for this project. Formal submittal to the Ohio EPA for the permit to install is scheduled for July 19, 2018.

Mr. Taylor reported that a portion of the sidewalk along East Wyandot Avenue between Rivers Edge and Duck Pond has been installed. The next phase of the project will begin tomorrow.

Mr. Taylor also reported that the grinder to be rented for the street and alley improvements within the City should be available in mid-July.

Mr. Thornton reported on a water leak which occurred recently along the east side of North Sandusky Avenue, near East Church Street. R.A. Bores was contacted to assist with the repair the leak.

Mayor Washburn reported that due to the July 4 holiday, all residential sanitation customers whose garbage would be picked up on Wednesday will be picked up on Thursday, July 5.

There being no further business, the Chairman declared the meeting adjourned.
