A motion was made by Mr. Voorheis, seconded by Mr. Spiegel, for the approval and payment of bills totaling \$125,857.76. Upon Voice Vote, all members voted Yes. The Chairman declared the motion carried.

The minutes of the January 2, 2018 Service Committee meeting, having been mailed to each Service Committee member, were approved as received.

Mr. Michael Thoma, Southeastern Equipment Co., Inc., was present to address the purchase of a street sweeper as discussed at the January 2, 2018 Service Committee meeting. Service Committee members inquired about where the equipment will need to be serviced if necessary. Mr. Thoma indicated that Southeastern Equipment has road technicians who can travel here for service calls. Extended warranties on the chassis and sweeper were also discussed along with some added accessories that were not presented at the previous Service Committee meeting including a remote grease manifold and a high pressure washdown system with a 50' hose reel.

A motion was made by Mr. Rowe, seconded by Mr. Voorheis, to amend the motion made at the January 2, 2018 Service Committee meeting regarding the street sweeper; and recommend to City Council to approve the revised quote from Southeastern Equipment Co., Inc. for the purchase of a A7 Tornado Street Sweeper, chassis, and accessories through the State Purchasing Program, at a total cost of \$209,106.00, including a trade-in allowance of \$40,000.00, and including five year extended warranties on the chassis and sweeper. Upon Voice Vote, all members voted Yes. The Chairman declared the motion carried.

Service Committee members commented that the Street Department employees are doing a good job plowing snow and removing the snow piles from the downtown area.

Mr. Thornton reported that the Water Department had to repair four water line leaks on North Seventh Street recently. Aqualine was called to sound for the leaks and pinpoint their locations.

There being no further business, the Chairman declared the meeting adjourned.
